**HUBUNGAN DUKUNGAN KELUARGA TERHADAP KEPATUHAN
DALAM MELAKUKAN KUNJUNGAN ANTENATAL CARE
DI PRAKTEK MANDIRI BIDAN R**

ABSTRAK

Latar belakang: Pelayanan *Antenatal Care* rutin meliputi intervensi medis serta saran-saran kesehatan yang diterima ibu hamil selama kehamilannya dan ini merupakan poin kunci bagi ibu hamil untuk mendapatkan pelayanan kesehatan dalam peningkatan kesehatan dan pencegahan komplikasi. Hasil survey dari 20 ibu hamil trimester III yang memeriksakan kehamilannya, hanya sekitar 40% ibu hamil yang patuh dalam melaksanakan kunjungan *Antenatal Care* secara rutin. Dan 60% yang tidak patuh dalam melaksanakan kunjungan dengan alasan suami tidak bersedia mengantar dan ibu lupa.

Tujuan: Penelitian ini Untuk menganalisis Hubungan antara Dukungan Keluarga Terhadap Kepatuhan Dalam Melakukan Kunjungan *Antenatal Care*.

Metode penelitian: kuantitatif dengan desain penelitian *Cross Sectional*, Teknik pengambilan sampel *purposive sampling* dengan jumlah *sample* 43 orang ibu bersalin dalam rentang waktu Juni - Juli 2024 di Praktek Mandiri Bidan R. Cara pengambilan data dilakukan dengan kuesioner. Analisis data menggunakan uji *Chi Square*.

Hasil: Sebagian besar dukungan yang diperoleh ibu dari keluarga ialah dukungan tidak baik (53,5%) dan sebagian besar ibu tidak patuh melakukan kunjungan *Antenatal Care* (55,8%).

Kesimpulan: Setelah dilakukan olah data dihasilkan bahwa Adanya hubungan yang bermakna antara dukungan keluarga terhadap kepatuhan ibu melakukan kunjungan *Antenatal Care* ($p=0,024$)

**THE RELATIONSHIP OF FAMILY SUPPORT ON COMPLIANCE
IN ANTENATAL CARE VISITS IN INDEPENDENT
PRACTICE MIDWIFER R**

ABSTRACT

Background: Routine Antenatal Care services include medical interventions and health advice that pregnant women receive during their pregnancy and this is a key point for pregnant women to receive health services to improve health and prevent complications. Survey results from 20 third trimester pregnant women who had their pregnancies checked, only around 40% of pregnant women complied with carrying out routine Antenatal Care visits. And 60% were disobedient in carrying out visits on the grounds that their husbands were not willing to accompany them and their mothers forgot.

Objective: This research is to analyze the relationship between family support and compliance in carrying out antenatal care visits.

Research method: Quantitative analysis with a cross-sectional research design, purposive sampling technique with a sample size of 43 mothers giving birth in the period June - July 2024 at the Independent Practice of Midwife R. Data collection was carried out using a questionnaire. Data analysis used the Chi Square test.

Results: Most of the support mothers received from their families was not good support (53.5%) and most mothers were not compliant with Antenatal Care visits (55.8%).

Conclusion: After processing the data, it was found that there was a significant relationship between family support and maternal compliance with Antenatal Care visits ($p=0.024$)
